FROM THE DIRECTOR'S DESK



It is my pleasure to place here a brief account of activities of A.N. Sinha Institute of Social Studies (ANSISS), Patna on record as an Annual Report for the year 2014-15. ANSISS has been actively engaged round the year with academic activities. Main highlights of the activities of the Institute for the year in reference can be categorised into a few broad headings, i.e., research, training, workshop, seminar, conference, lectures (foundation day lecture, memorial lecture), panel discussions, projects (completed, ongoing and initiated), and personalities visited at the Institute.

With the increasing strength of faculty members of the Institute and their engagement in various academic activities throughout the year it has visibly been showing results in organising national and international conference, seminars, workshops, trainings, carrying out projects, participating in national and international seminars and conferences; participating as panellists, delivering key note addresses and lectures, and publication of a research papers. Faculty members have completed 09 projects and submitted their reports to the funding agencies. A total of 10 projects are being carried out and 21 projects have been initiated on contemporary issues. Faculty members have published papers in various national and international journals. They visited abroad also to participate in international conference with papers. Faculty member of ANSISS bagged Gold Medal of Global Development Network out of 70 countries for research on development and transformation. Faculty members of the Institute published 27 research papers and articles in journals, 7 chapters in edited volumes, and 8 research reports. They presented 27 papers in national and international seminars and conferences as well.



Doctoral Fellows of the Institute have also been very much active. They have published 12 papers and presented 32 papers in various seminars. Institute has added 15 Doctoral Fellows sponsored by the ICSSR during the year in reference. Doctoral Fellows were also active in various academic and corporate activities of the Institute besides participating at various academic fora. The Institute has signed MoU with Aryabhata Knowledge University, Patna for Ph.D Degree besides Magadh University, Bodh Gaya, Bihar. Institute conducted Pre-Ph.D course for Doctoral Fellows of the Institute successfully.

Institute organized a Peace Leadership Conference on Building Nations of Peace: Our Shared Responsibility; Dr A.N. Sinha Memorial Lecture on 'Earth Democracy: Creating Living Economies that Work for the Planet and People' was delivered by Dr Vandana Shiva on 18 June 2014. Foundation Day Lecture on 'India after a Quarter Century of Liberalisation and Globalisation' was delivered by Prof. B.B. Bhattacharya, former VC, Jawaharlal Nehru University on 08 October 2014 besides many discussions and talks by national and international experts.

Corporate activities of the Institute have been shared collectively by various committees constituted by the Director. Institute has 21 committees to carry out academic and administrative activities – seminar, conference, workshop, training, rapporteurs report, editorial, annual report, library, computer, website, news, purchase, maintenance, grievance, construction, hostel and guest house, promotion, etc. The Institute is engaged in training of Revenue Officials – DCLR and COs in collaboration with Land Revenue Department, Government of Bihar.

Grants received for the year 2014-15 was Rs 3.40 crore from ICSSR and Government of Bihar and receipt from internal sources was Rs. 0.71 crore. Thus, total receipts were Rs 4.11 crore. However, expenses on pay and allowances alone were Rs. 3.57 crore. Other establishment expenditure was Rs. 0.77 crore and repairing and maintenance expenditure was Rs. 0.28 crore. Thus, altogether expenditure was Rs. 4.62 crore and deficit was Rs. 0.51 crore. Challenges to restore financial stability and academic vibrancy are enormous.

Institute is looking forward to financial flow in order to initiate the process of further recruitment on remaining vacant positions in Academic and administration. In order to restore and strengthen normal functioning of the Institute, it is expected that the ICSSR will release long awaited grants for this Institute for 5th and 6th CPC since 1996. ICSSR is still giving a block grant at Fourth CPC and not as per filled up positions. This happens to be the main reason for the slow growth of the Institute.

ABOUT THE INSTITUTE

Origin

A.N. Sinha Institute of Social Studies, Patna was established by the Government of Bihar in the memory of Dr Anugrah Narayan Sinha, one of the makers of modern Bihar and ardent follower of Mahatma Gandhi since Champaran Satyagraha. It was inaugurated on the 31 January 1958, by Desh Ratna Dr Rajendra Prasad, the then President of India. Later, it was made a statutory autonomous body through legislature on the 8 October 1964, under the A.N. Sinha Institute of Social Studies Act, 1964. The Institute is governed by the Board of Control and funded by the Department of Education, Government of Bihar and ICSSR through MHRD, Government of India.

Objectives

The objectives of the Institute as laid down in the Act are as follows:

1. To undertake teaching and research in social sciences;
2. To undertake study of specific problems, if and when required by the State Government or the Central Government or any other agency;
3. To provide for journals, books, pamphlets and other such materials as may be deemed necessary;
4. To organise lectures, seminars and conferences, and
5. To undertake other allied activities.

Research Area

The research interest of the institute broadly focuses on development and change, with special reference to Bihar and the Eastern region. Efforts have usually been made towards studying the mechanisms and processes of change in the wake of development, within appropriate theoretical and conceptual framework. Issues and problems within the above framework are identified and analysed towards finding their solutions.

Accordingly, researches of theoretical and empirical nature broadly diagnostic, evaluative and prescriptive nature, having relevance to the economy, society, polity of the country in general and the state of Bihar in particular, have been studied by the different faculties of the Institute. Special attention is paid to the study of the under-privileged and the rural poor, especially the Scheduled Castes, the Scheduled Tribes and women, and other socially and economically disadvantaged groups, within the disciplines of Economics, Sociology and Social Anthropology, Social Psychology, Political Science and Public Administration, Social Geography, Non-Violence and Peace and Statistics. The Institute has



multidisciplinary operational character and approach. Efforts have been made to take full advantage of the multidisciplinary structures of the Institute faculty. While each one of the disciplines pursues its own research programmes, there are a number of projects where members from different disciplines go together to analyse the social process from the angles of the respective disciplines so that an integrated view of the social reality may emerge. Over the years, there has been an appreciable expansion in its activities with a strong multidisciplinary faculty supported by a group of devoted research scholars for undertaking high level research in different branches of social science.

Today, it is one of the most prestigious social science research institutes in India. It has been recognised by the Indian Council of Social Science Research, New Delhi, as the Centre of Excellence in the field of social science research. Several international organizations including certain organs of The United Nations like UNICEF, World Bank, ILO, WHO, DFID, UNDP, etc., apart from the State Government and the Government of India, offer their research assignments to this Institute on a priority basis. Over the years, it has been seen as a model institution by the new and upcoming social science research institutions. It is also considered as the most important resource institution both by the government and their organizations. The Institute has acquired high status in the scholastic world by virtue of the quality of its academic activities. Apart from consolidating the research activities, efforts have been made for providing certain basic amenities like improved library services, photocopying facilities, duplicating facilities, renovated conference hall, seminar rooms, audio-visual appliances, etc. A developed computer centre caters to the needs of empirical and applied researches and for organizing data bank.

Campus and Resources

Main Building

The institute is located in a sprawling campus situated on the southern bank of river the Ganga at a distance of 2 km from Patna Railway Junction and in the Northwest end of the Gandhi Maidan. The location is picturesque



and has quiet surroundings, although it lies in the heart of the city. CDGP, Project

Building & Director's Bungalow The Institute has a spacious three-floor building for Academic Complex and attached to this is a separate two-storey building for the library, third storey of which is being erected. The administrative office is located on the first and second floor of the Research Block. There is a three-storey Hostel-cum-Guest House which provides accommodation to the visiting scholars.

Faculty and Staff Quarters

There are three duplexes (double-storied) stand-alone quarters for the senior faculty members, specifically constructed for them. There are some other types of quarters for faculty members and other staff of the Institute. The Director, some senior members of the faculty and essential staff have been provided with residential quarters on the campus. A building for the teaching faculty members has been proposed and the construction work is about to begin.

Gandhi Shivir

This campus has been a part of great heritage of freedom struggle. Mahatma Gandhi visited Bihar before Independence and stayed in this campus from March 6, 1947 to May 24, 1947 (except April 1 to April 14) adjacent to the house (presently the Director's Bungalow) of Dr Sayed Mahmood, the then Minister of the Government of Bihar. This glorious heritage of Bihar is recently restored by the Institute with support from the Government of Bihar. In the same building, the Centre of Non-Violence and Peace Studies is located.

Library

The library of the institute can claim to have outstanding collection of books, reports and journals in Social Sciences in Eastern region of the country. The library is

housed in its separate building of three floors. The second floor of the library was inaugurated on 1 December 2011 by Sri Nitish Kumar, Chief Minister of Bihar. Late Smt. Indira Gandhi, Prime Minister of India also paid visit to this library on the occasion of Silver Jubilee Celebration of this Institute on 4 January 1984.

Journal & Periodicals Section During 2014–2015 financial year, the library added 409 books and 86 reports and bound volumes of Indian and foreign journals. The Institute presently subscribes to 87 Indian and 33 foreign journals. The library also receives 26 journals on exchange programme. The library also subscribes some important national and foreign weeklies besides newspapers. At present, the Library holds 33038 volumes of books. In addition, there are 32888 bound volumes of journals and reports. Besides these, there are microfilms and CDs in the stock. Many institutions including ICSSR, New Delhi and individuals have been sending complementary copies of their publications to this library. Various government agencies, State Assembly, UNESCO, and ILO regularly send their reports and publications. Besides, the library has also received the entire personal collection on wide ranging subjects consisting of nearly 3,000 volume books as gift from Lok Nayak Jayaprakash Narayan (JP), which have been kept under separate section known as 'JP Collection'. The Institute's library has been designated as one of the Depository Libraries in India by international organizations like UNCTAD and UNESCO.



Journal & Periodicals Section

The library provides documentation services intermittently. A new term 'Bihar in Print', quarterly bulletin has been added to the documentation list. The bibliography service covers the following issues: Social and Cultural Change in India, Family Researchers in Asia, Tribal Life, Socio-Economic Study, Land Holdings of India, Women in India, Non-alignment, Naxalite Movement, Migration, Police and Policing in India, Muslims in Bihar, Schedule Castes: Their Status and Education, Communalism in India, J.P. Movement and Emergence of Janata Party, Violence, Urban Studies, Adult Education etc. which covers select



literature scattered in various journals and books on Bihar and Jharkhand since 1911. A new automatic electronic photocopier machine has been installed in the library to facilitate research endeavours of faculty members and research scholars.

Computer Centre

A.N. Sinha Institute of Social Studies has a full-fledged computer lab equipped with nearly 25 computers with high speed internet access having NKN support. The computer lab has been developed to enable the doctoral fellows to have adequate exposure to computer based research tools and access to research and development networks across the globe. With the support from ICSSR, the Institute is beginning to access some of the key e-resources, which the researchers can access in the computer lab for full benefits. Advanced statistical software is also accessible on case-specific basis and is in consideration for unrestricted availability. The lab is also being used by the project staff working under different research projects of the Institute.

Seminar & Conference Halls

The Institute has three airconditioned Conference/ Seminar Halls with all modern audio-visual facilities and good sitting arrangements. The largest conference hall has the capacity of 230 persons where generally conferences, seminars and public lectures are organized.

Seminar Hall No. 1 is of a moderate size having the capacity of 80 persons; and Seminar Hall No. 2 is of a smaller size of the capacity of 35 persons which is generally used for workshops, academic debates, discussions, meetings of the Board of Control, training programmes etc. Seminar Hall-1

Apart from these airconditioned Conference and Seminar Halls, the Institute has an open Hall on the second floor of the building, having a capacity of 80–100 persons, generally used for training, workshops, and other miscellaneous purposes.

Hostels and Guest House

The Institute has a good quality hostel-cum guest house, which serves both the purpose of hostel for the ICSSR Doctoral Fellows and the guest house for the visiting scholars and guests. It is a three-storied building. On the ground floor, there are six single and four double bedrooms with common bathrooms, a lounge and a dining hall. On the first

floor there are six single and four double bedrooms with common bathrooms, three single bedrooms with attached bathrooms and one single and one double airconditioned room with attached bathroom.

On the second floor, there are six single and four double bed rooms with common bathroom, four single rooms with attached bathroom and one single and one double room with AC and attached bathroom. Recently, a new guest house, named after Late Shri Madhu Limaye, a famous Indian Socialist Parliamentarian, has been constructed which is ready for use.

Research Priorities

This Division largely relate to micro and macro development: sectoral and spatial, agriculture, political economy of development, poverty, institutional and infrastructural questions, livelihood, nutrition, education, natural resource management, irrigation and water management, employment and labour, human development, development and welfare programmes etc. The dynamics of rural economy is being probed in all its diversities with special reference to the state of Bihar. A number of research projects have been taken up on these themes.

Research Priorities

The research interest of this Division lies in the exploration of culture of poverty with special reference to the Scheduled Castes and Scheduled Tribes and in ascertaining the role of women and their status in society. Similarly, the impact of changing technology, industrialisation, rural development and developmental planning on social structures receive attention of the faculty members of Sociology. From past some time, the faculty has developed experience and expertise in formulating, enacting, monitoring and evaluating various welfare and development programmes of government in the area of health, nutrition, children, women and other target groups. Problems of distributive justice, education and social stratifications constitute other important strand of research priority.

Research Priorities

This Division is devoted to the explanation of political progress and political dynamics especially in the state of Bihar. The research themes include political parties, pressure groups, movement, leadership, state politics, politics at the grassroots, electoral processes, politics and stratification, politics among the weaker sections and violence. Administrative process and the management of development programmes in different spheres are the other priorities. It also intends to provide for objective analysis of the planning and implementation of government programmes in respect of agriculture, health, education and welfare. Special emphasis is placed on administration at the district, block and panchayat levels with a view to suggest improvement in planning, coordination, supervision and execution of various programmes. Voluntary organizations constitute an important area of enquiry, receiving attention of the faculty members. The faculty also specializes in the study of the institution of Panchayati Raj in the state, human rights, particularly child rights protection, child labour, bonded labour etc.

Division of Social Psychology

Research Priorities

Division of Social Psychology focuses on social psychological research on social issues and problems for maintaining social harmony, peace, mental health, physical health and achieving wellbeing and happiness of individuals, society and nation. Some ongoing studies have been focussed on group behaviour, leadership, social power, student activism, child rearing practices, socio-psychological problems in school education, quality of working life, socio-technical systems in hospital organisations, mental health of adolescents, disability and rehabilitation of children, religiosity and secularism, gender issues, attitude towards dowry etc. Future research has been focussed on social security and old age, family dynamics, youth among marginal sections, malnutrition and children behaviour, food crisis and other issues of public health, climate change and human behaviours, conflict resolution and peace psychology, female foeticide etc.

Division of Statistics

Research Priorities

This Division has a multifarious role in social science research. It intends to provide the technical support to the other faculty members and to the Institute as whole for data management and also provides training in Research Methods. It is involved in various socially relevant training and research activities in the area of decentralized planning, disaster management, non-conventional energy uses, adult education/ literacy, primary education, vulnerability of the society in relation to transmission of HIV/ AIDS, agro-forestry, perspective planning, poverty measurement, Panchayti Raj institutions, voter behaviour, border area development etc.

RESEARCH CENTRES

The need for setting up some specialized centres has been felt desirable since long where it could be possible to conduct inter-disciplinary and multi-disciplinary studies in a comprehensive, longitudinal and cross-sectional frame. The idea of having specialized centres emerged out of the concern for the fact that the economy and social problems of the country are profoundly intertwined and complex in nature. As such, there is need for making a multipronged, collaborative attempt by drawing faculty from different disciplines. Setting up such centres, therefore, is a prerequisite for accomplishing the task in view.

Research Priorities

This Institute has been pursuing its research agenda in the direction of liberation of humanity, feudal exploitation, agrarian violence, social discrimination and injustices based on glorious heritage of Buddha, Mahavira and Gandhi, who contributed rare learning and knowledge. In order to take up thematically focussed task of research, teaching and training with contemporary relevance, the Institute has established this Centre for Non-Violence and Peace Studies which justifies the legacy of great heritage of non-violence. Basic objectives of this centre are to comprehend structural contradictions, conflicts and violence in the society, economy and polity towards refinement of concepts and development of theories of non-violence and peace with



contextual contemporary concerns, and to promote research, teaching and training, analyse the ground reality and contribute towards knowledge generation in the field of non-violence and peace for liberation of humanity.

Centre of Social Geography (CSG)

Research Priorities

Social Geography is primarily concerned with the ways in which social relations, identities and inequalities are created. How these social creations vary over space and the role of space in their construction is the principal distinction between sociology and social geography. Whereas the former emphasizes society, geographers emphasize the spatial: social geography is concerned with society and space. Such a concern is central to the larger body of work simply called human geography. This faculty will draw upon the political, the economic, and the cultural fields of geography, but the emphasis will remain upon the social issues affecting people's lives—class, 'race'/ ethnicity, gender, poverty, the body, health and well-being—and the role of space in the creation of social inequality and oppression, with particular emphasis on the Indian context. Basic objectives of this Centre is to identify several contemporary social inequalities from geographical perspectives; to explain and critique the economic, political and cultural processes creating and sustaining social and spatial inequalities; and to promote an awareness of social inequalities affecting the everyday geographies of people.

Centre for Educational Studies (CES)

Research Priorities

In accordance with the objectives spelt out above, the need for exploring and investigating different dimensions of education in the state as well as in the country has been strongly felt. This Centre prioritises the research on the Scheduled Castes, Scheduled Tribes and women, universalisation of primary education, structural inequalities in higher education, state intervention in educational development like the B.E.P. etc., factors impeding educational development and the role of non-formal education. Besides, the Centre evaluates studies of B.E.P., problem of elementary education with special reference to girl's education, etc.



Centre for Studies and Training in ICDS

Research Priorities

This Centre undertakes evaluative studies and impact assessment surveys of the ICDS programme in Bihar, offers suggestive measures for the elimination of bottlenecks in the implementation of ICDS and suggests planning strategies for making improvement in its implementation. The Centre also conducts training programmes and modular courses for the ICDS functionaries. Till date, the Centre has conducted more than 10 evaluative and impact assessment surveys sponsored by the Department of Social Welfare and other departments of the State and Central governments and the UNICEF. Some of these studies include formative study for developing media strategies; training of CDPOs & other ICDS functionaries; media support for child survival, training of anganwadi workers related to media support; strengthening of ICDS with World Bank Assistance; exclusion study in ICDS projects in Bihar, epidemiological survey in selected areas of Bihar; Time allocation study of Anganwadi functionaries in Bihar. The Government of India has sponsored the training programme for the ICDS functionaries to this Institute.

Child Right Protection & Child Labour Centre

Research Priorities

Child Labour Elimination Centre was set up for the purpose of organizing training programmes for Labour Enforcement Officers (LEOs), conducting evaluative studies, preparing child labour district profiles and to act as Resource Centre for Research, Training and Documentation Services. Till date, the Centre has organized workshops, training programmes for LEOs and other senior Labour Department functionaries. It has conducted district vision exercises. Prof. Nil Ratan was the Project Director of Child Labour Evaluative Studies. He visited United States of America between November 1 and November 21, 1999 in connection with delivering lectures on the problems of child labour in India in general, and in Bihar, in particular. He, among other places, was also invited to address at Child Welfare League, International Bank for Reconstruction, Department of Labour, all at Washington DC; Hunger Task Force, Department of Human Services at Ohio, UNICEF headquarters at New York. Prof. Nil Ratan was awarded the USIV Fellowship for his visit to the United States. Two certificate courses have been completed in Child Protection & Counselling. He is In-charge of Child Protection & Child Labour Cell. Two courses were completed during 2009-10. One of them was supported by the UNICEF and TISS where as another was conducted independently.



The Child Study Centre (CSC)

Research Priorities

The Child Study Centre (CSC) intends to provide for an integrated programme of interdisciplinary research, testing, training, counselling and welfare with a view to promote development and adjustment of children and adolescents in family and school systems. The activities of the centre are organized under five specific areas: testing, counselling, feedback to parents and teachers, growth sessions to adolescents, inter-disciplinary research, and the child family interactions.

Centre for Democratic Governance and Planning

Research Priorities

Initially this Centre was started with the funds from United Nations - Govt of India joint programmes on convergence through the Planning Department, Government of India. This Centre was designated as nodal institute for conducting training for urban sector professionals in Bihar under the Support Programme for Urban Reforms in Bihar (SPUR). Later on, this Centre has expanded its works in collaboration with various govt departments at State and Centre levels.

Centre for Disaster Risk Management

RESEARCH

Research Categories

Broadly, the research activities of the Institute can be placed under the following categories:

- Research carried out by one's own initiatives of the faculty members;
- Research for the degree of Ph.D undertaken by the doctoral fellows and other research scholars, supervised by the faculty;
- Research projects initiated by the Institute on social and economic issues of the marginal sections of the society, relating especially to Bihar; and
- Research projects sponsored and financed by the external agencies including the ICSSR, Government of India, Government of Bihar and other State Governemnts, and different international agencies such as the UN, World Bank, ILO, WHO, UNICEF, IDRC, UNFPA, UNOPS, NIPI, etc.

Research projects of the institute are categorised as:

1. Completed Projects
2. Ongoing Projects
3. Initiated Projects.

Completed Projects

1. Monitoring of Execution of Selected Schemes of Government of Bihar: Distribution of Bicycles, School Uniform and Scholarships, 2013-14

Sponsoring Agency: Department of Education, Government of Bihar

Research Team: D M Diwakar, Ajit K Hansda, Vidyarthi Vikas, Kaushal Kishor, Neetu Choudhary

Findings: The objective was to monitor whether the incentives provided under the schemes of Government of Bihar reach out to the beneficiary and to what extent. The schemes for which distribution of incentives was monitored included, Mukhyamantri Balak/Balika Cycle Yojna, Mukhyamantri Balak/Balika Poshak Yojna and Mukhyamantri Balika Protsahan Yojna. Apart from beneficiary outreach, the study also investigated into constraints and barriers encountered during the process of distribution. The study came out with interesting insights on varying performance of districts and divisions of Bihar with respect to different schemes.

2. India and Her Neighbours: An Initiative to Identify Opportunities and Outline Pathways for Expanding Bilateral, Sub-Regional and Regional Economic Cooperation in South Asia: Perspective from Bihar and Nepal

Sponsoring Agency: World Bank



Research Team: D M Diwakar, Neetu Choudhary, Abhijit Ghosh

Findings: The project was carried out in partnership with the Centre for Policy Research, New Delhi, - the central coordinating agency under the project, sponsored by the World Bank. The project focused on activities to expand regional economic cooperation in South Asia. While it was centred around the role of India - as the largest economy in the region and the one which shares a border with most of the SAARC countries - the activities extended to other countries in the region. The project adopted two pronged approach - one, focussed on enlarging the agenda for regional *economic* cooperation in South Asia and mobilizing a larger number of stakeholders in support of the agenda and two, creating supportive policies and capacity at national and regional leadership levels. Specifically, the project aims to conduct the background research followed by a brainstorming session, along following dimensions viz. assessment of the status of and barriers before the economic exchange between Bihar and Nepal, identification of informal and unaccounted transactions, and an assessment of the scope of expansion of economic cooperation between Bihar and Nepal.

3. Quality of Working Life, Quality of Life and Its Psychological Correlates in Bank Organization

Sponsoring Agency: ICSSR, New Delhi

Researcher: Dr S.M. Anwar Yousuf

Findings: The purpose of this study is to find out whether quality of working life and quality of life are inter-related or not? It also aims to find out relationship between quality of working life and other psychological variables. Inter-correlations based on the responses of Public Sector Bank Officers have been found. It shows that the variable *Quality of Working Life* has strong positive correlation with Organizational Environment and Self-Confidence whereas it is strongly negatively correlated with Organizational Stress and moderately negatively correlated with Personal Adjustment. The correlation between Quality of Working Life and Quality of Life has not been found significant but the relationship is in the positive direction as according to the response of Public Sector Bank Officers.

4. Implementation of Right to Education Act in the State of Bihar

Sponsoring Agency: Development Planning & Development Dept., Government of Bihar

Researcher: D.M. Diwakar.



Findings: This study is based on official and secondary data including government reports. Basic objectives of this study were to understand bottlenecks in implementing Right to Education (RTE) Act in Bihar. This report works out the gaps and challenges of hard and soft infrastructure for the implementation of RTE in Bihar and underlines the constraints in implementation of RTE, which need to be addressed with utmost sincerity.

5. Time on Task of Students and Teachers in Primary and Upper Primary School in Bihar

Sponsoring Agency: Bihar Education Project Council, Patna

Researcher: D.M. Diwakar and Minaketan Behra.

Findings: This study was aimed at understanding the pattern of classroom teaching-learning hours spent by the teachers and students in the elementary schools of Bihar and also to assess as to how these were performed. The study covered 100 sample elementary schools (70 Primary and 30 Upper Primary) from 10 sample districts of Bihar. This study concludes that the prevailing teaching learning environment and process involved in the elementary schools of Bihar desired to be conducive for good quality scholastic achievement of the students. The teachers were basically status quoists and they were concerned mainly in managing the students and not the quality of teaching within the classroom hours. As most of the students who get education in government run elementary schools belong to weaker sections of the society special attentions with targeted approach is required.

6. Evaluation of Preparatory Phase of Integrated Watershed Management Programme in Bihar

Sponsoring Agency: Dept. of Agriculture, Govt. of Bihar

Researcher: D.M. Diwakar, Aviral Pandey and Awadhesh Kumar.

Findings: The main objectives of this study were following:

- To obtain essential benchmark data related to the project.
- To identify outputs of preparatory phase given in the guideline.
- Identify the most common constraints and gaps.
- To suggest improvement in implementation processes.

This study is based on secondary as well as primary data. The secondary information was collected via consulting official records, reports, online MIS/project data base, minutes of meeting etc. Primary data study was consisting of household survey, Focus Group Discussions of primary beneficiaries, dialogue and multi stakeholder's meetings, and field visit to the



watershed sites (to verify the status of activities/works on the ground). Primary data was collected using a well- designed mix of structured and open ended Schedule from eight districts including Aurangabad, Banka, Gaya, Jamui, Kaimur, Munger, Nawada and Rohtash. The study applied multistage stratified random sampling design for selecting the households.

Integrated watershed management programme (IWMP) is a useful program for a state like Bihar. However, it was found that awareness about IWMP needs more serious efforts. And awareness programme among the people should be organised more extensively. Some watershed committees were not much found committed due to lack of interest of chairman, commonly nominated by the gram Sabha. In order to reinforce and maintain interest of the chairman, it was felt that at given the level of involvement, the chairman should be elected from the Self Help Group (SHG)/ User Group (UG). Efforts are required in selection of Entry Point Activities (EPAs). Transparency is a challenge in construction of EPAs. Some EPAs like solar lamps were not found functional at some places. This needs more attention. The training programmes organized by district level for the Watershed Development Team (WDT), SHG and UG need more serious efforts. The purpose of this programme is soil conservation, ecological balance, plantation, etc.; it should be communicated to villagers.

7. Monitoring of Rashtriya Madhyamik Shiksha Abhiyan (RMSA)

Sponsoring Agency: EdCIL (India) Limited, Ministry of Human Resource Development.

Research Team: D.M. Diwakar, Abhijit Ghosh and Renu Choudhary

Findings: A N Sinha Institute of Social Studies, Patna was entrusted by MHRD, GOI to study the status of secondary education in 17 districts of Bihar in the period of two years. In the first phase, nine districts (Begusarai, Jamui, Katihar, Khagaria, Lakhisarai, Munger, Patna, Saharsa and Sheikhpura) are selected for the study. Total 315 schools, 237 from rural and 78 from urban were chosen for the study. This study covers different aspects of secondary education such as teaching-learning, infrastructure, finance, planning & management, functioning of DPO and SPO. The main findings are:

1. Taking together regular and contractual teacher more than 31% of sanctioned teaching posts are vacant.
2. The percentage of girls' enrolment in class IX and X is below 40% Girls' enrolment is higher in rural schools than that of urban schools.
3. Pupil-Teacher Ratio (PTR) is 68.73. Rural PTR is higher than that of Urban PTR.



4. 70.79% of the school have the toilet facility. More than 50 per cent schools have no separate toilets facility for girls.
5. 50.2% rural schools and 69.2 percent urban schools have library facility. 38.7 per cent schools do not have laboratory facility in the school.
6. For class IX in rural areas there are 258.9 students per classroom and for class X it is 230.83.
7. There were 40 per cent schools where SMDC meeting was held during the last three months. There were 41.6% schools where sub-committee like tadarth samiti has been functioning as an interim arrangement.
8. The minimum and maximum Instructional Days was 114 and 293 days respectively in the previous academic year. The corresponding average figure is 237.40 days.

8. Educational Status of Scheduled Caste: Attainment & Challenges in Bihar

Sponsoring Agency: ICSSR, New Delhi

Researcher: Awadhesh Kumar

Findings: To find out the educational status of scheduled caste, the study was conducted in five sample districts namely Patna, Kaimur, Gaya, Siwan and Katihar. It was found that the performance of Scheduled Caste is increasing in schools and colleges but enrollment has increased in Primary only. Most of the SC people have left their caste based occupation and most of them have BPL Cards and some have modern household items. Now they are participating in college elections and showing political participation. SC students are getting benefits of Reservation in schools and colleges and hesitation and fear is also less now in asking something from teacher in the classes. Participation in games of SC students in schools and colleges has increased. The challenges are that enrollment is decreasing and dropout is increasing at secondary and college level of education. Leadership is still not given to SC students at secondary and college level. Discrimination still exists in the psyche of the people at school and society. It was also found that they were unaware about school and college schemes and no students reported about vocational trainings, capacity building, classes, free bicycle/bus pass and free guidance/counselling at secondary and college level.

9. Educational Status of Scheduled Caste: Attainment & Challenges in Jharkhand

Sponsoring Agency: ICSSR, New Delhi

Researcher: Awadhesh Kumar



Findings: The study was conducted in five sample districts of the Jharkhand state — Ranchi, Hazaribagh, Garhwa, West Singhbhum, and Sahibganj districts. In this state also the performance of Scheduled Caste children has increased in schools and colleges. Now Scheduled Caste people can also access the village main temple, panchayat, health centre, public transport and burial ground. Most of them have BPL Cards and some have modern household items. Scheduled Caste students are getting benefits of Reservation in schools and colleges. Participation in games of Scheduled Caste students in schools and colleges has increased. There are other concerns as well such as decrease in enrollment and increase in dropout at the secondary level of schooling and at college level of education. Leadership is still not given to Scheduled Caste students at secondary and college level. It was also observed that the Scheduled Caste students had problems in understanding classroom teaching and they do not have any educational background and family support at home and very limited accessibility to computers. In addition to this, there is unawareness about school and college schemes in students and their parents as well.

On-Going Projects

1. Socio-Economic Livelihood Study of Kosi Basin Programme in India

Sponsoring Agency: International Centre for Integrated Mountain Development (ICIMOD), Nepal

Research Team: D.M. Diwakar, Biplab Dhak and Aviral Pandey.

Purpose: This study aims to document socio-economic status, livelihood aspect and status of food security of inhabitants in the Koshi river basin in Bihar followed by adoption strategies at the individual as well as at the community level to constraints and hazards related to water and induced by climate change. Further, this study would evaluate policy impacts on upstream-downstream cooperation in reducing vulnerabilities and improving socio-economic conditions.

2. Dalit Assertion and Emerging Rural Social Formation in Uttar Pradesh

Sponsoring Agency: Indian Council of Social Science Research, New Delhi

Researcher: B N Prasad

Purpose: Aim of the study is to explore and analyse socio-economic changes among dalit community and its resultant impact on traditional rural structure. There is differential mobility among dalit sub-castes, which has discordant impact on rural structure; in terms of domination, interaction, socio-economic and political participation by dalit sub-castes. Inter and intra-interaction pattern between dalit and non-dalit; and within dalit sub-castes will also be



analysed. The objectives of the study are to indentify major infrastructural facilities, to assess degree of accessibility and change among dalits, to analyse major socio-political parameters, to identify major economic parameters, to analyse determinants of socio-economic change, to assess intra-dalit variation in terms of socio-economic status and mode of social interaction between dalit and non-dalit, and within dalits themselves. This study also intends to review policies and programmes, its implementation and delivery and to examine emerging rural socio-economic and political structures, and to suggest short term and long term measures.

3. Tracking of Children of Age Group 0-14 Years under SSA, BEPC, Patna

Sponsoring Agency: Bihar Education Project Council (BEPC), Govt. of Bihar

Researcher: Rajeev Kamal Kumar

Purpose: There is a mismatch between the Census and BEPC household survey data of children. Reliability of information is required for any programme implementation and intervention. The main purpose of this research study is to check the data and find out the missing children. However, the specific objectives of the study are: track the children of 0-14 years, to know the status of enrolment in different schools and special training centres, to know the status of dropout children, migratory children and CWSN etc. and to assess the situation of duplication in enrolment. For this study, both secondary and primary data will be obtained. Multi-stage random sampling will be followed and 8 panchayats and 4 urban wards from four districts of different divisions will be selected covering the maximum geographical area. The project is expected to complete by April, 2014.

4. Bihari Identity: An Uncharted Question

Sponsoring Agency: ICSSR, New Delhi

Researcher: Prof. Jyoti Verma (ICSSR Senior Fellow)

Purpose: The project aims to arrive at a comprehensive understanding of Bihari identity by looking into the different social sciences sources and empirical material on Bihari identity and as it has been explicated in the last 100 years or so. Questions such as: 'what is the regional identity of Bihari people' and 'how is it constituted' have remained unasked and barring a few Bihar based economists, psychologists in particular have hardly addressed to such concerns. Regional consciousness in the Bihari people expressed in terms of their passion, loyalty and fondness for their regional group. It aims to examine the impact of others' perception on identity construction and representation of a regional group by others and like to ask whether Bihari identity is a subset of



Indian identity and whether the two identities are likely to complement (or do not complement) each other. It would bring to notice the positions taken in the area of identity construction and regional identity of groups in social sciences literature particularly for the articulation of the concept of Bihari identity, and to integrate the empirical findings related to identity from the author's recent ICSSR report on 'Bihari migrants' with national and regional identities in order to advance the theoretical understanding of how regional identity is a historically evolved entity that is embedded in the larger identity-frame.

5. **Ethnographic Study of Mali (Malakar) Caste in Bihar**

Sponsoring Agency: Department of General Administration, Government of Bihar

Researcher: B.N. Prasad

Purpose: Social stratification is an integral part of traditional Indian social system. Over the period of time there is differential mobility among different caste groups, due to changing socio-economic conditions of the country. But fact remains that all social communities have not shared fruits of growth processes equally. Some have moved up in socio-economic ladders but many lagged behind. Mali (Malakar) caste of EBC in Bihar is one of such communities. The main aim of the proposed study is to explore and analyse socio-economic changes among Mali caste in the state. The specific objectives are to find out socio-economic, educational and cultural status of Mali caste; to find out their standard of living; to examine the nature of social relationship with notified Scheduled Castes and Tribes; to assess social handicap such as untouchability and other social relationship with other castes of the region; to find out changing pattern of occupation, etc. The study also intends to review policies and programmes for empowerment of the Mali caste, and to suggest short and long term measures to ameliorate their conditions.

6. **Ethnographic Study of Raj Dhobi Caste in Bihar**

Sponsoring Agency: Department of General Administration, Government of Bihar

Researcher: Rajeev Kamal Kumar

Purpose: The main purpose of the proposed research is to carry out the ethnographic study including the socio-cultural and economic life, social structure, inter-personal and commensal relationship etc. among the Rajdhobi caste of Bihar State. The objectives of the present study are to conduct a detailed ethnographic study of the Rajdhobi in the state of Bihar; to find out the socio-



economic and cultural status of the Rajdhobi caste and compared them with the Dhobi caste; to study the social handicap such as untouchability, rendering traditional services, commensal and other relationship with the neighboring or upper castes of the region; to study the level of literacy, occupational pattern, upward caste mobility, etc.; and to put forward a few suggestions based on the ethnographic findings.

7. External Monitoring & Evaluation of Resettlement Plan Implementation under Asian Development Bank (ADB) Loan

Purpose: The aim of the assignment is to document, monitor and study the impact and resettlement and rehabilitation dimension of the programme. However, the specific objectives of the present study are: to review and verify the progress in resettlement implementation as outlined in the Resettlement Plan (RP) of the BSPTCL; to develop specific monitoring indicators for undertaking the monitoring of RP; to review the results of internal monitoring and verify claims through random checking at the field level to understand whether land acquisition/resettlement objectives have been properly met; to identify the strengths and weaknesses of the land acquisition and resettlement, its objectives, approaches and implementation strategies; and to evaluate the adequacy of compensation given to the affected families in terms of livelihood opportunities, income and quality of life after the resettlement.

Under the production relations study will also explore the local capitalism to the some extent. The study will cover the institutional aspects of agriculture in arising Bihar. The study will explore various facts regarding farm-size and productivity/ profitability in context of Bihar.

3. to examine the relationship between fragmentation of land holdings and productivity and/ or Profitability;
4. to examine whether land productivity (profitability) varies under different tenure practices such as ownership, sharecropping, fixed rent, and mortgage etc.
5. to examine the market surplus across different category of farmers.
6. to suggest policy recommendation.

Seminar/Conference

A One Day Seminar on 'A Food Secure Bihar: Challenges and Way Forward', jointly organized by ANSISS, Patna and IFPRI, New Delhi on 06 August 2014

The workshop was initiated with floral welcome of the chief guest Sri Nitish Kumar, Former Chief Minister, Bihar and other guests of honour. Sri Nitish Kumar lighted the knowledge lamp, followed by welcome address by Prof. D.M. Diwakar, Director of the Institute. In his remarks, he said that the state has initiated many experiments such as Agriculture Cabinet, flagship programmes in agriculture sector under the dynamic leadership of Sri Nitish Kumar. Agriculture in the state has progressed well at the rate of 6% per annum in last few years despite the adverse climatic conditions of flood and drought. However, he emphasized that challenges to address concerns of small and marginal landless cultivators need to be addressed more effectively with regard to land and water management, along with forward and backward support system and institutional linkages. He appreciated IFPRI for providing the opportunity in working together on the issue of food security.

Dr P.K. Joshi, Director, South Asia of IFPRI has discussed about the IFPRI and the workshop. He informed the participants that the present workshop is part of a larger project in India which is being implemented jointly by IFPRI and Swiss Agency for Development and Cooperation (SDC). Dr Divya Kashyap, Senior Consultant, SDC has emphasised that the agriculture in India has been under pressure due to degrading resources such as land, water and uncertainty of the climate. She said that the adaptation to the climate change is necessary to sustain and increase the agriculture yield.

The chief guest, Sri Nitish Kumar acknowledged the invitation of ANSISS and congratulated ANSISS and IFPRI for organizing the workshop. About the Food Security Bill, he informed that Government of Bihar (GoB) has played an important role in preparing the bill and finally its enactment. Bihar will be



immensely benefitted with this Act as 74% urban and 85% of rural population of Bihar will be covered under Food Security Act. He also mentioned the challenges in implementing this act viz. storage and distribution of food grains among the beneficiaries, listing of beneficiaries. He has also suggested formation of an independent commission for identifying beneficiaries. Regarding production of grains, he said that the GoB has already prepared an exhaustive roadmap for the agriculture which takes care of production, storage, and marketing. Production includes not only the cereals but also pulses, oilseeds, fisheries, fruits, and other produce of horticulture. He also talked about the schemes and innovation undertaken by the State Government. He suggested avoiding chemical fertilizers. Chairperson of the session Sri I.C. Kumar, Former Secretary and Food Commissioner, Government of Bihar concluded the inaugural session.

There were three technical sessions and group discussions and valedictory. Parallel Session I was concerned with *Food Security in Bihar: Challenges and Opportunities*, chaired by Shisir Sinha, Principal Secretary, Government of Bihar and co-chaired by Ramesh Saran, Ranchi University. The speakers included: Anjani Kumar (IFPRI), P.K. Joshi (IFPRI), Praduman Kumar (IARI), and Aviral Pandey (ANSISS). Parallel Session-II was on *National Food Security Act: Components, Expectations and Opportunities*. The session was chaired by B.P. Bhatt (ICAR), and the speakers included Avinash Kishore (IFPRI), Habibullah Ansari (ANSISS), Abhijit Ghosh (ANSISS), and Reetika Khera (IIT New Delhi).

The Session III was Working Group Discussion, workshop was divided into three working groups with three specific themes viz. *Group-1: How to Strengthen Procurement of Food-grains in Bihar*, Group Lead –B.L. Mishra (CIMP) and Biplab Dhak (ANSISS); *Group-2: How to Make NFSA effective and efficient in Bihar*, Group lead were N.M.P. Verma (Lucknow University) and Aviral Pandey (ANSISS).

The Plenary Session: Way Forward was chaired by Jean Dreze (Ranchi University) and co-chaired by Sunil Ray (Central University of Bihar). The panelists included Amrit Lal Meena, (PS, Department of Agriculture, GoB), B. Pradhan (PS, Department of Food and Consumer Protection), D.M. Diwakar (Director, ANSISS), P.K. Joshi (IFPRI), and AN Sharma (IHD). At the end vote of thanks was proposed by Prof. B.N. Prasad, ANSISS to Chair, Co-Chair, panellists, presenters, participants and media.



International Workshop on 'Indo-Nepal Economic Cooperation: Sub-Regional Perspective from Bihar and UP' in collaboration with Centre for Policy Research, New Delhi at ANSISS on 16 July 2014

A N Sinha Institute of Social Studies, Patna with Center for Policy Research, New Delhi jointly organized this workshop. The inaugural session was chaired by Shri. D.N Sahaya, Former Governor of Chattisgarh and Manipur currently Chairman of ANSISS. Presiding over the workshop Shri D.N. Sahaya, said that India and Nepal, the two contiguous neighbors hold a long standing fraternal ties and ethnic link. These two countries in general and Bihar particularly shares a number of common concerns and hold immense potentialities for the promotion of trade and commerce, water resource and hydro power generation.

Rajiv Kumar, CPR, Delhi identified three core ideas in his paper titled “India and her Neighbours”. Firstly, India can't succeed without the success of its neighbours; secondly, being 83% of South Asian economy it is at the centre of South Asia and has to play a proactive role; and lastly, regional cooperation in South Asia cannot be successful if only directed from the capitals of the countries, the bordering states and elites have to play important role.

Prof. Vijay P. Mishra, Tribhuvan University, Nepal stated that trends of development in Nepal are not encouraging. Anil Kumar Sinha, Vice chairman, BSMDA, Government of Bihar, held that disasters and economic development are interlinked. The 2001 Bhuj earthquake led to 2% loss in India's GDP. The disasters can be tackled in a better way



through safe construction and strong public awareness and education. Nepal and India share hazards, disasters and vulnerabilities pattern. One must work at community levels to make it participatory and inclusive.

Prof. Diwakar, Director, ANSISS said India and Nepal share historical legacy and cultural connect formally and informally in terms of language, people to people relations etc. The major breakthrough was SAARC through which the aim of collective self-reliance was sought to be attained through social, economic political relations. One has to understand and explore the possibility of regional cooperation with guarded optimism like SAPTA and SAFTA and work together with collective wisdom.

The technical session started with two background papers on “Indo-Nepal



Regional Cooperation: Indian Perspective” presented by Neetu Choudhary, ANSISS and another presented jointly by Chittaranjan Senapati and N.K. Maurya (GIDS). It reflected on the current status of trade and other forms of economic cooperation, potential for greater economic cooperation and opportunities and barriers. The porous borders, historical and ethnic links (Buddhist and Ramayan), unaccounted trade, infrastructure, banking and exchange services, water cooperation holds the area to be explored between India and Nepal.

The first panel discussion on India–Nepal Economic Cooperation: Nepal Perspective’ was chaired by Bishnu Dev Pant, Executive Director, IIDS, Kathmandu, Nepal. The papers were presented by Purshottam Ojha (SAWTEE, Kathmandu); Harikrishna N (ICIMOD, Kathmandu); and Chandrakishore Jha (columnist, Nepal). The second panel discussion on Prospects of Indo-Nepal Cooperation was chaired by Rajiv Kumar, CPR, New Delhi. The papers were presented by Kanak Dixit (Editor, Nepal); A.K. Kulkarni (GM, COMFED, Bihar); Sudhir Kumar Singh (Patna Dairy Project Milk Union).

The discussion was enriched by active participation of research professionals, Faculty of ANSISS and ICSSR Doctoral Fellows. The discussion was coordinated by Dr Abhijit Ghosh, ANSISS. The closing remark was given by Sukanya Natarajan, CPR, New Delhi. The vote of thanks was given by Neetu Choudhary.

Discussion on 'Implementation of Food Security Act: Problem and Prospects' by Jean Dreze, Harsh Mandar and Reetika Khera on 10 July 2014

Dr Jean Dreze stated that implementation of food security act is a historic moment for Bihar. Food Security Act has provided three types of entitlement to the people of Bihar that includes Public Distribution System, Maternity Benefits for Pregnant Women and Child Nutrition. Hunger, nutrition and economic security are the objectives that Food Security Bill will surely cater to. The exclusion criteria that the Act has adopted in identifying the beneficiary with the help of Social Economic census 2011 will reduce the risk of exclusion of poor. Based on his brief visit to Araria, Muzaffarpur and Gaya in Bihar he argued that Bihar has done a good job in the implementation of Food Security Act. The coverage is large, criteria are well defined and notified and process of data collection is good. Its household listing, demographic data, economic data is reliable and accurate. The distribution of ration card is good and most people



have understood the new per capita approach. The areas that need attention are capacity building, reducing the risk of exclusion errors and making people aware of the allocation details. The method that Bihar has adopted under Food Security Act is transparent and can be a model for implementation in other poor states like Jharkhand, Odisha.



Dr Reetika Khera focussed on the working of Public Distribution System in Bihar. On demand side she argued that extended coverage, reduction in price and diversification of basket is needed, while on the supply side computerization, management of shops, official commissions, doorstep delivery and regularity

and predictability will better the working of Public Distribution System. The Food Security Act aims to fulfil much of it.

Shri Harsh Mander, Supreme Court designated Food Commissioner, stated that the most important part of Food Security Act is universal maternity benefit because the first 1000 days are important for the development of child. The arrangement should be made that the lactating mother is available to the child with going through financial distress. He also argued that some social categories must be included universally like single women headed household, musers etc. Vulnerable groups and migrants needs must be included in the Act. However the real time analysis becomes most important.

Shri Shishir Sinha, former Principal Secretary of Food and Civic Supply, Government of Bihar, stated that the allocation to the state has gone up to 456000 metric tons per month. The leakage problem can be solved through total digitization of the Public Distribution System. I.C. Kumar, former Chief Secretary, Government of Bihar argued that appropriate commission is needed to stop theft and corruption in the system and storage facility improvement is viable.

Prof D.M. Diwakar, Director of ANSISS stated that it is the matter of concern that provision in Schedule III for sustainable food rights through structural addressed mechanism for agricultural development needs attention, towards effective implementation of National food security Act. The discussion was enriched by active participation of research professionals, social activists, administrative professionals, faculty of ANSISS and ICSSR Doctoral Fellows.



Peace Leadership Conference on 'Building Nations of Peace: Our Shared Responsibility' on 8 September 2014

That event was organized by Universal Peace Federation of India in collaboration with Centre for the Study of Non Violence and Peace of A.N. Sinha Institute of Social Studies, Patna. It was inaugurated by Shri D.N. Sahaya, Chairman of this Institute, Dr Chung Sik Yong the Chairman of Universal Peace Federation (UPF), Asia. Welcome address was delivered by prof. D.M. Diwakar, Director ANSISS. Mr. Krishna Adhikari, Secretary General, UFA introduced the Universal Peace Federation and its works all around the world.



Inaugural address was given by Dr Chung Sik Yong. He highlighted the history of Federation. He praised India for its Peace March efforts and said that India can play very critical role because it has been seen as beacon of moral and spiritual light. He stressed that Selfishness is destructive always and everywhere. The UPF conferred the award of 'Ambassador of

Universal Peace' upon Sri D.N. Sahaya. He expressed his views in his Presidential address that though the world has come to a close neighborhood it is seething with explosive forces disturbing peace in the world. The present generation has to decide whether it wishes to have a new peaceful world and violence free world or destruction of mankind.

Dr Robert S. Kittel, Director of Education, UFA-Asia in his presentation stressed that everything is based on principles. Sacrifice is important for goodness. Selfishness is problem for family, industry and society.

Prof Ramjee Singh, former VC, Jain Vishva Bharti University, Rajasthan, in his keynote address, stated that family is the seed of peace. Peace is two-fold - external and internal. He emphasized that we should now come with *Jai Jagat* with *Jai Hind*. Ecological and Environmental degradation is bigger problem for establishing peace. He further said that misuse of religious principles and Nationalism generates hatred, which is a big threat to World Peace. Dr Razi Ahmad, Secretary, Gandhi Sanghralay, Patna said that it is the role and responsibility of third world countries in the path of establishing peace and harmony in third world countries. Developed nations are working for their comfort and growth on the name on peace. If we provide justice to marginal people then only we can see the realization of the dream of World Peace.



Seminar on 'Challenges of Communal Harmony in India' organized by A N Sinha Institute of Social Studies, Patna, 21 March 2015, ANSISS, Patna

The seminar was delivered by Shri Manoj Mitta, Senior Journalist, Times of India and an activist. Shri Mitta stated that the issue of communal harmony has been much in vogue since incumbency of NDA government at the Centre with immediate reasons being frequent religious remarks by the RSS chief and ministers, RSS' campaign on Love Jihad and Ghar Wapsi, legal leniency towards convicts of Gujarat riot, attacks on churches and the sudden designation of Christmas as Good Governance Day, Maharashtra Government's decision to ban slaughter of any kind of cattle and so on. Shri Mitta argued that what has been of more concern is the mute response on the issue from the Government as well the Opposition Party.



Shri Mitta further stated that these questions cannot be answered without going back to the events of 2002 which helped the centre to capture the imagination of the Hindutva constituency. He did not refer to the Bhartiya Janata Party as communal as against the Congress part as secular. One of the lessons the speaker stated to have drawn from studying Indian Politics and Communal situation is the impunity of accountability for those who engineered communal violence. Shri Mitta explained that leaders who presided over massacres targeting minority communities are allowed to get away with the claim that the violence was an unavoidable expression of public anger. The pattern of evidence yielded by official fact-finding actually shows that public anger is a necessary – but not a sufficient – condition for egregious violations of communal harmony. Whether it is Delhi in 1984 or Gujarat in 2002, the violence, Shri Mitta argued, could not have escalated without political instigation and administrative complicity.

The seminar was chaired by Prof. D.M. Diwakar, Director, ANSISS, and active participation from activists, academicians and social scientists was witnessed following the lecture.

Seminar on 'Samaj aur Sahitya' organized by A N Sinha Institute of Social Studies, Patna and Sambhav on 6 February 2015 at ANSISS, Patna

Several women shared their experiences on the subject including those who have solemnised inter-religion marriage and underwent the challenges encountered therein.

The debate reflected at length in attempts to curtail women's freedom and mobility on moral pretexts. It was discussed how the government and public policies bypass the voices for women's freedom and deliberately choose to divert focus on women's empowerment by external efforts. It was observed that much of the piecemeal approach is actually an attempt to maintain the patriarchal order of the society.



WORKSHOPS/ TRAINING PROGRAMMES

Administrative Training of Land Reforms Officials sponsored by Department of Revenue and Land Reforms for DCLR and CoS, funded by Department of Revenue and Land Reforms, Government of Bihar (on going, in different batches)

A.N. Sinha Institute of Social Studies, Patna in collaboration with Department of Revenue and Land Reforms, Government of Bihar has organized a series of training programmes on Bihar Land Reforms Acts, Rules, and Circulars for Government Officials of Bihar dealing with issues of Land such as ACs, DCLRs, and COs of the state of Bihar from September 2014.



The First Training Programme was organized during 17-20 September 2014.

Land reform has greater potentiality for rural development and rural reconstruction. Policy initiative has been initiated by the center as well as by State government just after Independence. Some positive result has been observed but major objective of land reform is needed to be achieved. The Programme was inaugurated with lighting the lamp by Sri Narendra Narayan Yadav, Minister, Revenue and Land Reforms, Government of Bihar and other guests. Chief Guest Sri Narendra Narayan Yadav, Minister, Revenue and Land Reforms, Government of Bihar in his deliberation highlighted the problems of redistribution of land such delay, ill-treatment to petitioner,



avoidance of rule and regulation in settling the cases, with this background he appealed to officials to work with knowledge, sensitivity and synergy. He gave information about **Operation Basera** for Dalits and STs initiated by government to provide homestead land and progress of this programme.

Sri Vyas Ji, PS, Department of Revenue and land Reforms, highlighted that main obstacle is paucity of data and land records. He also explained the importance of cadre building for unfinished agenda of land distribution. He wished that sensitivity, skill and knowledge will be imparted through this training which will help to achieve the agenda of land redistribution. A.N. Sinha Institute of Social Studies, Patna and Department of Revenue and Land Reforms, Government of Bihar both are sharing this responsibility. Success of Operation Bargha related to land distribution in West Bengal is a good example we can look forward.

Prof D.M. Diwakar briefed about the programme and asserted that Land Reforms are one of the major weapons to eliminate poverty. Historically people movements and leadership had always been spine of land reform programmes. After Independence, the problem of land distribution in India as well in Bihar has been the agenda but it is yet to be achieved. In this training programme, land revenue officials would be sensitized towards concerns of marginalization and deprivation. The officials were oriented towards disputes resolution. The training involved lecture by " Bhudan and Yagya: Act and Rules by Shubh Murti and team, followed by "Bihar Privileged Persons Homestead Tenancy Act, 1947" by Suraj Prasad. The post lunch session, discussion was focused on Bihar Mutation Act, 2011 by Vinod Jha followed by discussion on "land Acquisition resettlement and Rehabilitation Act, 2013. The training programmes were coordinated by Dr Vidyarthi Vikas, ANSISS, Patna.

The second batch was again for the DCLRs of different districts. *Next Training Programme on Land Reforms was for DCLRs of Bihar was held between 6-9 November 2014.* It was inaugurated by Shri Vyas ji, Principal Secretary, Department of Revenue and Land Reforms. Prof. D.M. Diwakar, Director ANSISS, Great Gandhian Prof Ramji Singh, social activist Shri Pankaj ji, Prof Pushpendra of TISS, Mumbai; Shri Shubhmurti Ji, Shri Pradeep Priyadarshi of Ekta Parishad participated.



The Second Batch of Training Programme on Land Reforms was held between 6-9 October 2014.



Prof. Pushpendra, TISS, Mumbai, reflected the fact that though Zamindari System has been abolished but the distribution is still not fair. Land is transferred to superior and inferior tenant not to the tillers. With the time land holding size has decreased but transfer is still skewed. He supported the idea that social opportunity cannot be provided in the absence of resource. We need to eliminate the negativity from judicial intervention.



Social Activist working on grassroots level highlighted the fact that without the support of State and Governance implementation of land reforms will not be effective. Past three-to-four years Government of Bihar is working positively towards the unfinished agenda. Great Gandhian Shri Ramji Singh, discussed about the land

distribution and acquisition problem prevailing all over the world especially after new economic reforms in India Government, MNCs and Land Mafia are aggravating the land issue; is the macro picture.

Honourable Minister Sri Narendra Narayan Yadav, Department of Revenue and Land Reforms, discussed about Operation Basera and Operation Dakhal Dehani and appreciated the work which provide homestead land to almost 3 lakh, 87 thousand Dalits. He emphasized that elimination of intermediaries is important for success of land reforms programme.



The Fourth Training Programme for COs was organized during November 26-29, 2014.

Shri Basant Choudhary, Advocate and a Social activist, mentioned that success of capitalism also depends on land reforms. Revenue system and Law and order plays important role in Land reforms. Shri Kapileshwar ram, Dalit Vikas Manch, stressed on moral values and Shri Shubh Murti, Chairperson, Bhoodaan Yagya Samiti reflected on ideas of Binobha Bhawe. Shri Ashok Vardhan, Member, Bihar fifth finance commission enriched the officials in context of land reforms Background and Act 1950 of Bihar land reforms.

An independent body should be formed solely responsible for the management and monitoring of government land.

that Public Policy is eclipsed by delivery mechanism of State and Centre. Eventually this problem defeats all the noble attempt of Public policies and marginalized and poor people are subjugated due to poor delivery system. The major task is to strengthen the delivery mechanism.

A lecture on 'Reflections on Indian Diaspora' by Prof. Parmatma Sharan, City University of New York, USA, on 17 January 2015



Inaugural function was graced by Shri Narendra Yadav, Minister of Revenue and Land reforms; Shri Hukum Singh Meena, Secretary, Food and Consumer Protection; Shri Subhmurti ji, Member, Land Reforms Core Committee; Prof. D.M. Diwakar, Director, ANSISS; Shri Kapileshwar Ram, Dalit Adhikar Manch; Ms. Kalpna from Planning Commission and others. Shri Hukum Singh Meena stressed

Prof. Sharan focused on how the Indian identity issue is dealt by the people of Indian origin in the USA. He reflected how Diaspora is a historical phenomenon and those who have migrated earlier belonged to the lower strata of the society. Majorly two issues are faced by immigrants; firstly, Discrimination they face, and secondly, how to

maintain their Indian identity. He explained how language, religion, use of internet and social media has played a major role in maintaining the Indian identity. He discussed about the ways Indians have absorbed with the diaspora, without losing fundamental identity. He traced that the shift in profile of Indian immigrants to USA is due to the changing global profile of Indians and their empowerment in all walks of life. He appreciated the recognition by Indian Government, and how remittances have enhanced the Indian economy performance. The main challenge in front of Indian Diaspora is to find the ground for Immigrants to maintain their Indian heritage.

Special Lecture by Dr Tira Faran, Research Scientist from Commonwealth Scientific and Industrial Research Organization (CSIRO), 12 December 2014.

Dr Faran shared his research work on Koshi basin mainly focussed on Technical Water Resource Modeling. His research was based on Interviews of Government officials, technical water experts, NGOs and Policy think tanks. Through his scholastic presentation he shared his preliminary findings. Assumptions were based on two research questions. First, can modeling as a social technical activity lead to greater mutual understanding of development benefits and tradeoffs within the





Koshi Basin? Secondly, what other influences might modeling have a transboundary water relations between India and Nepal? The main findings were politics by India and Nepal is worsening the natural calamities. He also presented that participatory, transparency and deliberative approach were vital for the success of this Technical Water

Resource Modelling.

Prof. D.M. Diwkar, Director of this Institute said that Water Resource Modelling should be culturally people centric model, rather than only being technical model. Development discourse directs the governance and management of water resource. It is important to look the issue from the micro perspective. That approach was appreciated by the audience and few major issues were raised like study on the cultural aspect, addressing the historical effect, incorporation of micro aspect of society, dynamics of class and caste and their coping strategy should be incorporated in the study. Faculty and ICSSR Doctoral Fellows joined the lecture and enriched the deliberation.

Special Lecture on 'Contemporary Water Issues in Bihar' by Prof Kamta Prasad 14 November 2014.

Prof. Prasad is known as a specialist on water issues. In his discussion, he emphasized on interdisciplinary research. He presented how holistic and integrated approach can produce pro people policy. Human as a subject cannot be seen isolated with only a



single discipline so it is important to go with holistic and an interdisciplinary approach. He raised the issue that objectivity is missing from contemporary Indian scholars. He said, "Don't be a consumer of ideas but be the producer of ideas". He discussed on water policies in Bihar and Gujarat, and how government is taking up the issue. Prof. Bhattacharya in his lecture said that even after a quarter of liberalization and globalization, India continues to be one of the poorest countries in the world. India of 21st century suffers from inequity, inter-sectoral imbalances, regional inequity and inter-personal income disparity. He elaborated that



there is however political stability but the side effects of disparities continue to plague India. He emphasized that contrary to the wide held opinion that these disparities originated from liberalization, they actually were omnipresent even during planning era. India could not reap the fruits of liberalization because of neglect of human capital formation and health facilities.

The main driving force behind globalization was the foreign exchange shortage. These reforms were introduced in Asian economies gradually after establishing the economy and human capital formation but in India they were introduced as a fiscal policy and in the crisis situation. The lack of human capital led to the inability of India to take up high end technology in manufacturing, whereas China took the maximum benefit of foreign capital to expand its labour intensive manufacturing base for exports. He pointed that the current economic growth of India has been attributed to international competition in technical services and this in turn is a result of knowledge of English that India has tried to develop and the due to less controversial nature. Now, the other Asian economies are trying to catch up India on this part.

Dr A.N. Sinha Memorial Lecture on 'Earth Democracy: Creating Living Economies that Work for the Planet and People' by Dr Vandana Shiva on 18 June 2014



Dr Vandana Shiva, an environmental activist and anti-globalization author, enlightened the audience with the concept of Earth Democracy – putting people and planet at the heart of the economy; respecting rights of Mother Earth. 'Earth Rights' is the rights of Mother Earth, and our corresponding duties and responsibilities to defend those rights.

Right of Mother Earth gives us an opening to reclaim human freedom and freedom of life on earth. It also includes right of humans as they flow from the rights of Mother Earth – the right to food and water, the right to health and safe environment, the right to the commons- rivers, seeds, bio-diversity and atmosphere. She explained the fact that how war against earth begins in the mind and its contemporary seeds were sown when the earth was transformed into dead matter to facilitate the industrial revolution. The dominant paradigm of development and growth is working to grab global resource for corporate profits. It is in this context of violence and injustice the call for making peace with the earth through earth democracy becomes most important ecological, social justice and human rights movement of our time. It is a great challenge to go beyond 'free market democracy'; to create real freedom through living democracies.





Now-a-days green economy is presented as a cure but it is important to understand that corporate green economy is based on privatization and commodification of the earth resources whereas, earth centered green economy is based on recovery of commons and intrinsic values of the earth and all her species. The later will make peace with the earth and will address the problem of hunger.

Much praise about growth and progress omits the reality that economic growth hides the poverty it creates, both through destruction of nature, and nature's ability to provide goods and services, as well through destroying the self-provisioning capacities of societies and communities. Every aspect of life commercialized and commoditized, living becomes more costly, and people become poorer. She further highlighted the current development models which demand more resources and leading us to resource wars — oil wars, water wars, food wars. And this induces violence against earth expressed as ecological crisis, violence against people in the form of poverty, destitution and displacement and violence of wars and conflict.

In her lecture she appraised the Gross National Happiness measure by Bhutan and appealed to construct more measure like this. A world based on cooperation, compassion and care from the individual to the international level can be achieved through path of earth democracy. She heavily criticized the practices of privatization, Patent Rights and TRIPS. Ecological security and reclaiming control over our food, water and air is an imperative for our collective future. Living democracy is the space for exercising our common responsibilities and duties to protect life on earth, defend peace and promote justice. Prof. Nil Ratan proposed vote of thanks.

Seminar on 'Emerging Face of Fascism', jointly organized by Hastakshep and ANSISS, Patna, on 24 May 2014

Special Talk on 'Food, Water and Energy Nexus in South Asia: Relevance in Bihar Context' by Dr Golam Rasul, ICIMOD, Kathmandu, Nepal on 27 March 2014

Dr Rasul discussed as to how with limited land resources, inadequate energy supply, and growing water stress, South Asia are facing the challenges of providing enough water and energy to grow enough food for the burgeoning population. Using secondary data from diverse sources, he explores the food, water, and energy nexus from a regional



dimension, emphasizing the role of Hindu Kush Himalayan (HKH) especially Bihar ecosystem services in sustaining food, water, and energy security downstream. His analysis reveals that the issues and challenges in the food, water, and energy sectors are interwoven in many complex ways and cannot be managed effectively without cross-sectoral integration. He pointed out that there is huge need of food grain production in India. At given resource constraint, Bihar has ample of opportunities. Besides having potential, farmers of Bihar are getting low support by the government in terms of other states like Punjab and Haryana. In terms of water, Bihar has huge potential in terms of ground water. Government support to farmers for the energy can improve farm production and reduce cost of production in Bihar. Finally he concluded by saying that Bihar has the potential to be the granary of India. Prof. D.M. Diwakar pointed out that food security is a demand side as well as supply side problem and this issue should be discussed keeping both sides. He proposed that soil nutrition and a proper coordination of soil and water management policy is needed to improve the agriculture production in Bihar and other states of India. This seminar was attended by faculties, doctoral fellows of this institute. Prof. A.K. Jha, Dr Sudhir Kumar, Dr Habibullah Ansari, Dr Biplab Dhak, Dr Aviral Pandey, Dr Abhijit Ghosh, , Sri Mallik participated in the discussion. The vote of thanks was proposed by Professor Nil Ratan.

PH.D. PROGRAMME

Ph D programme at A N Sinha Institute of Social Studies is designed to develop issue based, inter-disciplinary, applied as well as pure research orientation among the students so that they could understand the local, regional, national and international problems. The programme lays larger emphasis on different dimensions of social science to provide an integrating framework within which various developmental and changing issues can be addressed.

Ph. D. programme involves successfully completion of a six month course-work followed by the submission synopsis and formal registration in Ph D Programme. Ph D Course is being affiliated to the Aryabhatta Knowledge University, Patna (Final letter of conformation is awaited).

Pre- Ph.D Course Structure and Duration

Main purpose of Pre-Ph D course work is to encourage fundamental research aptitude among the research scholars, through systemic training in computer aided research methodology and interactions with contemporary social science debates. The underlying intent is to prepare the students for theoretical rigor as well as applied understanding. At the end of the course the students are expected to be familiar in review of research literature, designing and developing their own research and locate it in the ongoing discourse of their areas.

Pre-Ph D course has been structured as per the guidelines of UGC. Students are required to undertake three papers (Two compulsory papers- one research methodology and another computer application/ data analysis to all students and one elective paper from their subjects) which are completed in six months. Evaluation of this course will be done through a written examination followed by an internal assessment.

Fellowship

Institute provides ICSSR Doctoral Fellowship to Ph D students up to a maximum 15 students each year. Applications are invited for the award of this Fellowship in Social Science preferably in subjects: Economics, Agriculture Economics, Sociology and Anthropology, Political Science and Public Administration, and Social Psychology, Social Geography and Non Violence and Peace. Candidates having Post Graduate degree in Social Sciences with JRF/NET/M Phil are eligible to be shortlisted for a written test followed by the interview for these fellowships. As per ICSSR guidelines selected candidates shall be paid a fellowship amount of Rs.16000/per month plus Rs.12,000/- per annum as contingency grant for two years extendable by one year in exceptional cases only. In case of an employed



scholar his/her salary will be protected in addition, a contingency grant of Rs.12000/- per annum will also be paid. Duration of salary protected fellowship will, in no case, be more than two years. Allocation of Fellowship for successful SC and ST candidates will be allocated as per guidelines of ICSSR. Women, minorities and candidates from educationally backward states are considered on priority basis. Application on prescribed format with a synopsis is required to apply. 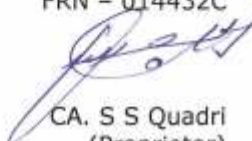

We have audited the attached **Balance Sheet** of **A. N. Sinha Institute of Social Studies**, Patna - 800001 (Bihar), for the Year ending **31st March 2015** and also the **Income and Expenditure Account** for the year ended on that date annexed thereto; and

We report that: -

1. Interests on Bank and other deposits have been accounted for on receipts basis, except where bank deducted tax (TDS). Interest on Fixed Deposits of different Funds have not been treated as income, since the same forms part of the fund and shown under Schedule "3". An amount of ₹ 7,62,667.00 from interest has been added to Corpus Fund (GOI).
2. The Institute is maintaining various bank accounts broadly classified under two heads. First is "**Non-Earmarked Fund**" which is used for administrative purpose. It is shown as "**Total - B**" in **Schedule "6"**. Whereas second one is "**Earmarked Fund**" which is used only for Specific Purposes. It is shown as "**Total - C**" in **Schedule "6"**.
3. Expenditure incurred against specific Funds / Grants from Govt., of Bihar and Indian Council of Social Science Research, New Delhi and Grants received for various projects are based on departmental/Institute identification and allocation.
4. Amount received against any Project is treated as Liabilities under schedule "3" from the financial year 2011-12. Expense incurred against this Project is adjusted out of the same project. The **Institute's** share commonly known as "Overhead Charges" is treated as Income. It was explained that "Overhead Charges" on various projects has been charged regularly but in some cases it was not charges due to non-receipt of final instalment. It will be charged when received. Expenses incurred on various projects are subject to Separate Certification for sending to Funding Agencies.

5. Revenues are recognized on cash basis except in case where Tax has been deducted and amount has not been received till the end of the Financial Year. Government Grants and Grants for Projects are recognized as and when it is received.
6. Project Advance and other advances as per List needs adjustment after obtaining proper supporting documents from the respective person to whom advances were sanctioned.
7. Annual physical verification of the items of fixed assets and other stocks owned / Possessed by the **Institute** has not been carried out. As such the actual position of the assets concerned and their reconciliation with the books could not be ascertained.
8. TDS Certificate is required to be obtained from various agencies and bank on quarterly basis. In 26AS, one TDS entry is for ₹ 1,500.00 deducted by DIRECTORATE OF ADULT EDUCATION DELHI is standing for amount shown to be paid ₹ 75,000/-. This needs verification.
9. Books of Accounts of the Institute are maintained on Tally software besides this Manual Cash Book is maintained.
10. Depreciation has been charged in the accounts on WDV basis as per the rates of income Tax Act, 1961. Details are as per schedule "4".

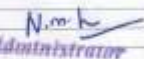
